Street Fair Vendor Space (approx. 20'x10') Retail & Food Vendors......\$135. per space

\*Themed Vendor Space....(Antique Dealers 5/16/10, Artists/Craftsman 6/13/10)
Spaces only available on Chestnut Street and vendor must meet criteria......\$100. per space (early registration and Chamber Member discounts can apply to this space)
Those seeking to be Themed Vendor must fill out Theme Vendor Contract\*

Early Registration Discount if paid in full by April 30, 2010 – choose either a) or b):

- a) 1 spot for all 3 Street Fairs = total cost to vendor: \$300.00
- b) \$25. discount per space (-\$25. per space)

**2010 Suffern Chamber Member Discount**: \$35. discount per space ....(-\$35. per space)

### **Vendor Contract/Rules for Vendors**

- 1. It is the sole responsibility of Food Vendors to obtain the proper permit from the Rockland County Dept. of Health (845) 364-2600 or (845)364-2606. Failure to obtain the permit will result in removal from the fair, without refund.
- 2. It is the sole responsibility of all vendors to collect and pay NYS Sales Tax and each must have a current NYS Sales Tax Number and certificate attached to their application. Contact NYS Dept. of Taxation and Finance at 1-800-225-5928 for a DTF No. 17 if required.
- 3. Certificates of Insurance for Food Vendors and rides must be attached to the application and must evidence Comprehensive General Liability with limits not less than \$1,000,000 per occurrence/\$2,000,000 aggregate, and statutory Workers' Compensation Insurance. The Certificate must name the Suffern Chamber of Commerce as "Additional Insured."
- 4. Check-in time begins at 7:00 am. Prior to 7:00am, vendors will be asked to wait in assigned municipal lot (Lot B) and will not be allowed to block traffic on street. Check-in MUST be completed and vehicles removed NO LATER than 9:30am.
- 5. Vehicles must be unloaded and then parked in municipal parking lot. No vehicles will be allowed on sidewalks! Any vendors requiring their vehicle be part of their exhibit MUST have written approval prior to event by the Suffern Chamber of Commerce.
- 6. Vendors must supply their own set-up equipment. Space size is equal to one parking space (approx. 20'x10'). Please note that many 10'x10' tent poles extend outward If so, 2 10'x10' tents will extend past the allotted space. Tents will NOT be allowed to exceed allotted space and infringe on others' space. Vendors must have attractive displays. No bare tables tablecloths necessary.
- 7. Vendors shall occupy only the space assigned by The Suffern Chamber of Commerce. No Vendor will be allowed more than 10' from the curb THIS WILL BE STRICTLY ENFORCED.
- 8. Electric is NOT available. If an exhibitor requires electric power, they must provide their own generator and have approval from The Suffern Chamber of Commerce in advance. No noisy generators will be permitted.
- 9. Spaces will be assigned on a first received (multiple show) priority system. Returning exhibitors will be given next priority. Food/Retail Vendors are assigned before Non-Profits, which may be assigned to side streets.
- 10. ABSOLUTELY NO fireworks, smoke bombs, silly string or snappers, rude, hazardous or objectionable items will be permitted. The Suffern Chamber of Commerce reserves the right to eliminate any items for sale which are deemed unacceptable or in conflict with street fair guidelines.
- 11. Suffern Merchants and Vendors: Sub-leasing or allowing businesses to operate in space they reserved in strictly prohibited. Only the business whose tax id number/business name will be allowed to operate in that space.
- 12. Vendors are required to list the products that they sell on their application (use the back of the application if necessary to list all types of products). Products not listed on the application that are in conflict with other nearby Vendors, may be restricted from selling those items that are in conflict or not listed on application.
- 13. No religious or political soliciting permitted!
- 14. Absolutely NO Refunds. Fairs are Rain or Shine!
- 15. Vendors are required to keep their area clean and free from debris. Vendor is responsible for their own garbage (bags will be provided). Vendors who do not comply will not be allowed to participate in future fairs.
- 16. A Vendor's inability to appear at the Fair, for any reason, will not result in a refund.
- 17. Tear down begins at 5:00pm and all Vendors must have their exhibits broken down and vacated by 6:00pm to allow clean up by the DPW. Vehicles will not be permitted on the streets until 5:00pm.
- 18. If you are submitting your contract as a "Non-Profit," you must include paperwork documenting your organization's non-profit status.
- 19. Each Street Fair will have a different theme. Themed spaces are available only on Chestnut Street and are assigned by prior approval of the Chamber. These spaces will be at a discounted price stated and vendors must submit a "Theme Street Fair Contract."
